#### Dear Mr Doyle:

Thank you for your letter dated September 19, 1988 informing us of the councils decision to offer the cross country skiing equipment and facilities of Nelson for use by the Miramichi Cross Country Ski Club. On behalf of the club executive I would like to thank you and the village council for this generous offer.

Subsequent to receiving your letter and our meeting with the Nelson council and Jim Wolstenholme, the MCCSC executive have met to discuss the proposal. At this meeting there were a number of issues and concerns raised which I would like to pass on to you for review by council.

The executive have decided that when the club is relocated the clubhouse and other buildings will be moved to the new site and utilizied in some fashion. In the event that the new Chalet becomes a reality we could use the old clubhouse for a Jackrabbit building or for a waxing building. Another area of major concern is that of trails. Presently about 95% of the membership are recreational skiers and require trails that are relatively flat terrain and long enough to accommodate the needs of the seasoned skiers. Presently the MCCSC maintains a 1, 2.5, 5, 7.5 and a 15km trail network. Also on trails, there should be the potential for a loppet trail of between 25 and 40 kms. This would not need to be in place prior to a move and we do not see this as being a problem.

Another very important issue is that of a long term lease on the land where the club would be located. Presently, the MCCSC club is entering it's seventh year of a ten year lease from the Village of Douglastown. A long term lease is necessary in obtaining certain types of grants and funding from government programs. It also reassures the club of the commitment by the Municipality for the long term viability both for the club and the sport in general.

Basically, because of the lack of adequate recreational trails at the Nelson site and our commitment to hosting a Loppet during the 1988/89 season, we do not feel that we could accommodate a move to the Nelson site before the spring of 1989. This, however, may not be that bad as it will give Nelson time to develop recreational trails at their site as well as giving the MCCSC membership a chance to ski on the Nelson trails and become familiar with the location through our reciprocal membership arrangement. We could then exercise our option at the Annual general meeting in early April to finalize the decision.

Overall, if the decision is to relocate the MCCSC club to the Nelson site, we would like to make the transfer a smooth one with little disruption and as many of the membership in tack as possible. We also would like to offer as much assistance as possible to the Nelson club in the area of designing trails and in any other way we can.

I trust that this will meet with council's approval and look forward to hearing with you.

## Assuming no grant/s forthcoming:

- 1 The Miramichi Cross Country Ski Club will be governed entirely by the club executive as it has in the past. This includes controlling trails setting policies and guidelines regarding the use of the trails and facilities and the setting of all programs for the season.
- 2 There must be adequate recreational trails in place prior to start of ski season. All recreational trails must be relatively flat terrain & suitable for beginners and older skiers.

Minimum requirements would be:

- 1. A 2-3 km trail.
- 2. A 5 km trail.
- 3. A 10-15 km trail.
- 3 No ski trails except a loppet trail will cross an open road or follow an existing skidoo trail.
- 4 The existing clubhouse and Jackrabbit building must be relocated and used by the club. The existing clubhouse must be supplied with water, electricity and sewage.
- 5 All skiing facilities at Nelson site to be used entirely for cross country skiing activities during the ski season unless otherwise approved by the MCCSC executive.
- 6 MCCSC executive to be responsible for the selection & hiring of all trail and clubhouse workers.
- 7 A letter of commitment from the Village of Nelson allowing the MCCSC ski club to operate at the Nelson site for a period of time (to be mutually agreed upon between MCCSC and Nelson).

## Questions arising from above items:

- From 2. How much funds are available from the Village of Nelson?
- From 3. This may be a problem. Will have to be investigated.
- From 4. How much funds are available from the Village of Nelson?
- From 5 & 6. Is this a problem?
- From 7. Would ten years be acceptable?
- From 1,4,5,6. Same would apply if new ski chalet becomes a reality.

The Miramichi Cross-Country Ski Club recently decided it would have to relocate. Among the factors influencing the difficult decision are the following:

- 1. McKinnon Road is now open year round and cuts the trails;
- The forest fire destroyed all of the cover north of the McKinnon Road leaving the trails exposed to wind and drifting. Also, the dead trees are continually falling onto the trails;
- The trails are not secure one land owner doesn't want us on his property and has forbid further trail development. Other land developers are coming closer to the trails each year.

We sincerely appreciate the offer to use Village land on Williston Road Extension. This site would have made the club more accessible to members but the fire damage would still be a problem and the land in that vicinity is serviced and ripe for subdivision development.

We examined several alternative sites but most either suffered damage from the 1986 forest fire or did not offer security for the trails. We ultimately chose to amalgamate with the Nelson ski club which now has a variety of wooded trails and plans to develop a further eight to ten kilometres this summer.

Village of Douglastown - 2 - April 16, 1991 This will be the fourth move for the club, and we regret having to leave Douglastown after ten years.
